## Information for members attending

- 5. Election of the officials of the Club, the convenors, the ordinary members of the Management Committee
  - a. With reference to the Rules of the NER Sports Club Incorporated, rules 13 (2) and (3) state that "Subject in the case of the first members of the Management Committee to section 21 of the Act, the Management Committee shall consist of (a) the officials of the Club; (b) the convenors; and (c) 3 ordinary members." and "The officials of the Club shall be (a) the president; (b) the vice-president; (c) the treasurer; and (d) the secretary."
  - b. Rule 14 (1) states that "Nominations of candidates for election as officials of the Club, as convenor, or as ordinary members of the Management Committee (a) shall be made in writing, signed by two (2) members of the Club and accompanied by the written consent of the candidate (which may be endorsed on the form of the nomination); and (2) shall be delivered to the secretary not less than fourteen (14) days before the date fixed for the holding of the annual general meeting at which the election is to take place."

- c. Rule 14 (4) states that "If the number of nominations received is equal to the number of vacancies to be filled, the persons nominated shall be deemed to be elected".
  - i. The positions of President, Vice-President, Secretary, Treasurer, Netball Convenor, Tennis Convenor, and Football Convenor are therefore deemed to be elected as per above
- d. Rules 14 (5) and (6) state that "If the number of nominations received exceeds the number of vacancies to be filled, a ballot shall be held." and "The ballot for the election of officers, convenors and ordinary members of the Management Committee shall be conducted at the annual general meeting in such usual and proper manner as the annual general meeting may direct."
  - i. A ballot is therefore required to determine which of the 5 nominees for

### 6. Motions on Notice

- 7. Election of Life Members and Playing Life Members
  - a. With reference to the Rules of the NER Sports Club Incorporated, rule 3 Life Members states that:
    - i. "(1) Any person who has rendered outstanding service to the Club may upon the recommendation of the Management Committee be elected a life member of the Club at an annual general meeting of the Club by seventy five percent (75%) of those present and entitled to vote."

#### 8. General Business

- a. With reference to the Rules of the NER Sports Club Incorporated, rule 30 Notice states that:
  - i. "(3) No business other than that specified in the notice convening a general meeting shall be transacted at the meeting except, in the case of an annual general meeting, business which may be transacted pursuant to rule 28(2).
