2. Confirmation of the minutes of the 61st Annual General Meeting held on 3rd December 2023

3. Business arising from the 2023 minutes

3. Receipt and adoption of the Annual Report / Financial Report and Auditor Appointment

Craig Denyer congratulated the club and section award winners, thanked the convenors and Ben Heard for their contributions

Craig Denyer noted that the club was in a favourable financial position

Craig Denyer moved and Warren Joslin seconded that the Annual Report and the Financial Report (as reviewed by the Club's Auditor) and as circulated, be received and adopted.

5. Acceptance of nominations and election of officials of the Club, the convenors, and the ordinary members of the Management Committee for 2023

With the current Committee in place until the conclusion of the AGM, and considering there being no other nominations for President, Craig Denyer remained in the chair

With reference to the Rules of the NER Sports Club Incorporated, rules 13 (2) and (3) state that "Subject in the case of the first members of the Management Committee to section 21 of the Act, the Management Committee shall consist of -(a) the officials of the Club; (b) the convenors; and (c) 3 ordinary members." and "The officials of the Club shall be -(a) the president; (b) the vice-president; (c) the treasurer; and (d) the secretary."

Rule 14 (1) states that "Nominations of candidates for election as officials of the Club, as convenor, or as ordinary members of the Management Committee – (a) shall be made in writing, signed by two (2) members of the Club and accompanied by the written consent of the candidate (which may be endorsed on the form of the nomination); and (2) shall be delivered to the secretary not less than fourteen (14) days before the date fixed for the holding of the annual general meeting at which the election is to take place."

The following nominations were received by the prescribed date, with consent included from the relevant nominee:

Craig Denyer announced that following discussions with several of the nominees, he had received nomination withdrawals from Steve Colquhoun and Sam Lyndon, negating the need for a ballot for the Ordinary Member positions.

Greg Friend withdrew his nomination, leaving the position of Football Convenor open.

Craig Denyer asked for nominations from the floor, Greg Friend nominated Warren Joslin, the nomination was seconded by Nicki Walsh, and Warren accepted the nomination.

No further nominations were raised.

Craig Denyer thanked Steve Colquhoun (General Member) for his 30 years of commitment to the NER Committee, and also thanked Greg Friend (Football Convenor) for his effort over the last two years, and Sam for his interest in a committee position.

Rule 14 (4) states that "If the number of nominations received is equal to the number of vacancies to be filled, the persons nominated shall be deemed to be elected".

There being only one nomination received for each position, all positions were therefore deemed to be elected.

Craig Denyer congratulated the new Committee and welcomed Reinis Grauds as the newest member.

Auditor Appointment

Craig Denyer moved and Matt Walker seconded that Andrew North of North Financial Services Pty Ltd (c/o A North, PO Box 1002, Epping NSW 1710) be appointed as the auditor for 2022-2023.

Craig Denyer provided the following update regarding the NER/NEBCC Merger Discussions:

As most should be aware we have been in discussions with the Bowling Club over the last couple of years with the view to a merger of the two Clubs.

The concept of "One Community, One Club" remains to be the focus, as was supported by the member survey results.

Also as a result of our member survey, two main areas of concern for the members were highlighted. These being governance and finance, and the two Clubs have been working together to ensure these two things remain equitable for all.

We are continuing the process of seeking further and independent advice, and performing our due diligence, and are keen to receive the results of that.

We had ambitiously anticipated a merger occurring around now, but crossing the T's and dotting the I's takes time, and I am sure no-one would expect this process to be rushed.

And as a final note, the merger is not about "us" and "them", but "we".
